

Finance and Banking Management

Offered jointly by INSCAE and IAE of Lyon (France) and preceded by a one-year of common core course within the framework of Master Finance, the training program leading to Master Finance and Banking Management contains studies lasting for one year including six months of theoretical courses and six months of professional internship in a company. A joint degree is issued if the overall assessment of exams proves successful.

➤ Objectives of the training:

The overall objective of the training is to impart managers' knowledge and skills needed for a successful career in the field of finance, bank management and microfinance, or a related field.

At the end of the training, participants will develop a good knowledge of methods and tools adopted in the field of finance, bank management and micro-finance and will become true professionals in these areas.

➤ Entry Requirements:

The programme is devoted to:

- holders of DESCA or DHEF issued by the INSCAE;
- students from the Master I - Option Finance of INSCAE.

➤ Course Syllabus:

The training contains theoretical courses (spread over the first 6 months) and a professional internship in a company (during the second semester) for the preparation and completion of the final dissertation.

The program comprises the following teaching units (TU):

TU1 - Bank / Microfinance and Methods Module (18 credits)

TU2 - Finance Module (12 credits)

TU3 - Internship and Thesis module (30 credits).

➤ Teaching methods:

- Courses taught by visiting professors from IAE Poitiers, INSCAE and professionals;
- Theoretical courses, case studies, group work, individual or group oral presentations, followed by ongoing assessment of knowledge and written examinations.

➤ Graduation

The degree is awarded to students who:

- have followed the lessons diligently and have an overall score of at least 10/20 in order to be admitted to prepare and support the final dissertation;
- have the required minimum mark (10/20) at the defense of the final dissertation.

➤ Control of Knowledge:

The examination session is held at the end of each course. A check on each instruction will be marked out of 20 points.

The final dissertation, attesting the candidate's ability to present the results of his research, will be marked out of 80 points. A score below 40 points (10/20) will be eliminated.

Lessons

Master in Accounting Control Audit

After one year of common core course within the framework of Master Finance, the training programme leading to Master in Accounting Control Audit contains studies lasting for one year including six months devoted to theoretical courses and six months of professional internship in a company, sanctioned by the Master's degree which is co-issued by INSCAE and IAE of Poitiers (France).

➤ Overall Objective of the Training Programme:

The overall objective of this training programme is to provide necessary skills and knowledge to become high level auditors, accountants and management controllers.

➤ Intended Learning Outcomes:

At the end of the training, students will be able to:

- Control punctually and in a hindsight the regularity and sincerity of documents and accounting procedures
- Drawing up summary reports on the accounting or financial situation
- Advise new accounting or financial procedures
- Have a legal background and knowledge in accounting computer systems
- Have a good command of the methods and tools of verification
- Become real professionals in the field of external or internal audit.

➤ Entry requirements:

The training is for:

- holders of DESCA or DHEF issued by INSCAE;
- students from Master 1-Option Finance of INSCAE

➤ Course Syllabus:

Management Control and Audit

After one year of common core course within the framework of Master Finance, the training programme leading to Master in Management Control and Audit contains studies lasting for one year including six months devoted to theoretical courses and six months of professional internship in a company, sanctioned by the Master's degree which is co-issued by INSCAE and IAE of Poitiers (France).

➤ Objectives of the Training Programme:

This training programme aims at training management controllers, budget controllers, project managers, business analysts, quality auditors, owners of management information systems, and quality consultants. The corresponding diploma allows students to move towards accounting and financial expertise or to perform the functions of general or specialized management controllers.

➤ Entry requirements:

The training is for:

- holders of DESCA or DHEF issued by INSCAE;
- students from Master 1-Option Finance of INSCAE

The training contains theoretical courses (spread over the first 6 months) and a professional internship in a company (during the second semester) for the preparation and completion of the final dissertation.
